


Figure 1-1 Overview of Type I Camera




Figure 1-2 Overview of Type II Camera

Note:

• The item marked with the "*" is only supported by certain camera models.



 Press RESET about 10s when the camera is powering on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.



2 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12 VDC or PoE (802.3af). Make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall or ceiling is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precaution to prevent IR reflection:

Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.

2.1 Memory Card Installation

This series of cameras support memory card installation. Different camera types share the similar installation steps, and we take type I camera as the example.

Steps:

1. Loosen the lock screw to remove the sun shield.






Figure 2-1 Remove the Sun Shield

2. Rotate the front cover counterclockwise to remove it.




Figure 2-2 Remove the Front Cover

3. Insert the memory card into the memory card slot.






Figure 2-3 Insert the Memory Card

- Rotate the front cover clockwise back to the camera and install the sun shield back.
- 5. Tighten the lock screw clockwise to fix the sun shield.




Figure 2-4 Fix the Front Cover



2.2 Camera Mounting

This series of cameras support the ceiling mount. Different camera types share the similar installation steps, and we take type I camera as the example.

2.2.1 Direct Mounting

Before you start:

Camera of these types is equipped with a bracket. It can be mounted to a wall or a ceiling directly.

- Attach the drill template (supplied) to the wall or the ceiling where the camera is to be mounted.
- Drill screw holes in the wall or ceiling according to the drill template.




Figure 2-5 Drilling Holes in the Wall/Ceiling



- If you need to route cables through the wall (or the ceiling), cut a cable hole according to the drill template. Skip this step if you want to route the cables on the surface of the wall (or the ceiling).
- 4. Route the cables of the camera.
- Secure the camera to the wall (or the ceiling) with the expansion screws.




Figure 2-6 Secure the Camera

6. Adjust the view angle.

3-axis (pan/tilt/rotation) adjusting allows adjustment for optimum camera rotation and placement. Follow the steps below to adjust the view angle.

Pan Adjustment

Steps:

- 1). Loosen the lock screw 1.
- Adjust the panning position of the camera. The adjusting range is from 0° to 360°.
- 3). Tighten the lock screw 1.

Tilt Adjustment



- 1). Loosen the lock screw 2.
- Adjust the tilting position of the camera. The adjusting range is from 0° to 90°.
- 3). Tighten the lock screw 2.

Rotation Adjustment

- 1). Loosen the lock screw 3.
- Rotate the rotation position to adjust the azimuth angle of the image. The adjusting range is from 0° to 360°.
- 3). Tighten the lock screw 3.




Figure 2-7 View Angle Adjustment

- 7. Adjust zoom and focus (refer to 2.3 Zoom and Focus Adjustment).
- (Optional) Install the waterproof jacket for network interface. Refer to 2.4 Waterproof Measures for detailed installation procedures.



2.2.2 Mounting with a Junction Box

Before you start:

The junction box is not included in the package. You need to prepare one for this mounting type.




Figure 2-8 Mounting with a Junction Box

- Attach the drill template (supplied) to the wall where the camera is to be mounted and drill holes in the wall according to holes on the drill template. See Figure 2-5.
- If you need to route cables through the wall (or the ceiling), cut a cable hole according to the drill template. Skip this step if you want to route the cables on the surface of the wall (or the ceiling).
- 3. Secure the junction box to the wall (or the ceiling) with the expansion screws.
- 4. Hook the camera to the junction box with the safety rope.
- (Optional) Install the waterproof jacket for network interface. Refer to Section 2.4 Waterproof Measures for detailed installation procedures.



 Route the cables of the camera. Connect the interfaces to the power on the camera to see if you can get an image on your monitoring screen.

Note:

If you can't get the image, check the power and network connection before performing the next step.

- 7. Secure the camera to the junction box with the screws.
- Adjust the view angle. Refer to Step 6 in Section 2.2.1 Direct Mounting.
- 9. Adjust zoom and focus (refer to Section 2.3 Zoom and Focus Adjustment.

2.3 Zoom and Focus Adjustment

2.3.1 Manually Adjustment

Certain camera models of this series have the lens that zoom and focus levels must be manually adjusted via zoom/focus lever and you can use zoom lever and focus lever to adjust the lens.

- Remove the sun shield and front cover to expose the zoom lever and the focus lever.
- Loosen the zoom lever and move the lever between T (Tele) and W (Wide) to obtain the desired angle of view.
- 3. Tighten the zoom lever.
- Loosen the focus lever and move the lever between F (Far) and N (Near) to obtain the optimum focus.



- 5. Tighten the focus lever.
- 6. Install the sun shield and the front cover back to the camera.




Figure 2-9 Zoom and Focus Adjustment

2.3.2 Motor-driven Lens

Certain camera models of this series are equipped with a motor-driven lens. You can adjust the zoom and focus level on PTZ control panel by visiting the camera via web browser or client software.




Figure 2-10 Zoom and Focus Adjustment via Web Browser



2.4 Waterproof Measures

If the camera is installed outdoor, you should use the waterproof accessory or tapes to waterproof the cables. Otherwise the cables might get wet or a short circuit occurs.

2.4.1 Install Network Cable Waterproof Jacket




Figure 2-11 Install Waterproof Jacket

- 1. Feed the network cable through 1 and 3 in order.
- 2. Fix (2) on the network cable between (1) and (3).
- 3. Place (5) onto the end of (6), and plug the RJ45 male connector into RJ45 female connector.
- 4. Screw (3) to (6) clockwise.
- 5. Push (2) into (3).
- 6. Secure (1) with the (3) in clockwise direction.



2.4.2 Waterproof Other Cables

After routing and connecting the cables, use the waterproof tapes to wrap up the cables. Connected cables and spare cables both should be wrapped up as the figures below.




Figure 2-12 Waterproof Cables



3 Setting the Network Camera over the LAN

Note:

3.1 Wiring

Connect the camera to network according to the following figures.




Figure 3-2 Connecting via a Switch or a Router



3.2 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via web browser, activation via SADP, and activation via client software are all supported. We will take activation via SADP software and activation via web browser as examples to introduce the camera activation.

Note:

Refer to the User Manual of Network Camera for activation via client software.

3.2.1 Activation via Web Browser

Steps:

- 1. Power on the camera. Connect the camera to your computer or the switch/router which your computer connects to.
- 2. Input the IP address into the address bar of the web browser, and press Enter to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- The computer and the camera should belong to the same subnet.
- For the camera enables the DHCP by default, you need to use the SADP software to search the IP address.

3.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.



Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts.

Follow the steps to activate the camera.

Steps:

- 1. Run the SADP software to search the online devices.
- 2. Check the device status from the device list, and select the inactive device.

Create and input the new password in the password field, and confirm the password.

4. Click Activate to start activation.

You can check whether the activation is completed on the popup window. If activation failed, make sure that the password meets the requirement and try again.

3.3 Modifying the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC.

Use the SADP software or client software to search and change the IP address of the device. We take modifying the IP Address via SADP software as an example to introduce the IP address modification.



For IP address modification via client software, refer to the user manual of client software.

- 1. Run the SADP software.
- 2. Select an active device.
- Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

4 Accessing via Web Browser

System Requirement:

Operating System: Microsoft Windows XP SP1 and above version

CPU: 2.0 GHz or higher

RAM: 1G or higher

Display: 1024×768 resolution or higher

Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

Steps:

- 1. Open the web browser.
- In the browser address bar, input the IP address of the network camera, and press the Enter key to enter the login interface.

Note:

- The default IP address is 192.168.1.64. You are recommended to change the IP address to the same subnet with your computer.
- 3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).



4. Click Login.

Install the plug-in before viewing the live video and managing the camera. Follow the installation prompts to install the plug-in.

Note:

You may have to close the web browser to finish the installation of the plug-in.

For detailed instructions of further configuration, please refer to the user manual of network camera.



5 Operating via Hik-Connect App

Purpose:

Hik-Connect is an application for mobile devices. With the App, you can view live image of the camera, receive alarm notification and so on.

Note:

Hik-Connect service is not supported by certain camera models.

5.1 Enable Hik-Connect Service on Camera

Purpose:

Hik-Connect service should be enabled on your camera before using the service.

You can enable the service through SADP software or web browser.

5.1.1 Enable Hik-Connect Service via SADP Software

5.4 Initializing the Memory Card

Steps:

Check the memory card status by tapping on the Storage Status in the Device Settings interface.

If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event triggered video in the camera such as motion detection.
